Contracts with Medical Laboratories

The Supplemental Report of the 2017-18 Budget Act contains language requesting that the University of California (UC) report to the Legislature information on its contracts with medical laboratories. That request reads as follows:

<u>Item 6440-001-0001—University of California</u>

- 1. University of California—Contracts With Medical Laboratories. On or before January 1, 2018, the University of California (UC) shall report to the Legislature on the following issues:
- (a) the number of outside medical laboratories for which UC currently contracts;
- (b) the value of each contract;
- (c) a summary of any efforts UC has made to date to consolidate its contracts with outside laboratories; and
- (d) a summary of Vizient's recommendations to UC on consolidating contracts with outside laboratories.

Background

UC Health represents and includes UC's five academic medical centers located in San Francisco, Sacramento, Irvine, Los Angeles and San Diego. While the Clinical Laboratories at each UC health system provide very robust testing menus, our medical centers must use reference medical laboratories because our UC laboratories cannot provide every test needed by clinicians to diagnose and treat patients. Some tests are patented and only available at a few laboratories, while others are of such low volume or require highly specialized knowledge that it becomes necessary to utilize reference medical laboratories.

In aggregate, the UC's five academic medical centers utilize eighty-five reference medical laboratories. These are listed in Table 1 with their aggregate spend.

Contracts with Medical Laboratories

UC Health established the "Leveraging Scale for Value" Initiative, aimed at identifying and achieving cost savings and operational efficiencies for UC's clinical enterprise. By coordinating as a single network of health systems, UC Health facilitates master contracts and obtains better terms and pricing from the suppliers who can deliver the level of clinical quality and service required. Responsibility for selection of clinical laboratories, including reference medical laboratories, rests principally with laboratory directors. Master contracts can and should ensure appropriate pricing and service terms for reference medical laboratory services, but the ultimate selection is driven by the clinical judgment of laboratory directors. Laboratory directors must evaluate potential reference medical laboratory services based upon numerous factors, including quality, service delivery, test menu, professional expertise, turnaround time, test ordering and result reporting processes, utilization reports, and other management tools and

services. Cost is not the only factor in selecting a reference medical laboratory for a contractual relationship. This is consistent with the College of American Pathologists' accreditation guidance, which requires that the laboratory director, in consultation with the institutional medical staff or physician clients (where appropriate), be responsible for selecting reference medical laboratories. This decision must be based primarily upon the quality of performance of such laboratories. Failure to comply with this guidance is considered an accreditation deficiency.

As a part of the Leveraging Scale for Value initiative, UC Health has established two master contracts with reference medical laboratories. These include GeneDx (a division of BioReference Laboratories) and ARUP Laboratories. When available, UC Health utilizes an already established contract with Vizient Inc., a group purchasing organization (GPO) of which the University of California, UC Health, and its five health systems are members. As a GPO, Vizient is able to aggregate the purchasing volume of the several health care providers that participate in the GPO, using that leverage to negotiate discounted pricing with vendors. For the contract with ARUP Laboratories, UC Health utilized a Vizient contract to consolidate. For clarification, this move was one decided on by UC leadership and not Vizient.
